- 7. Bids must be submitted on www.bolpatra.gov.np/egp before 12:00 on April -23, 2020. Bids received after this deadline will be rejected.
- 8. The bidswill be opened in the presence of Bidders' representatives who choose to attend at 14:00, on April -23, 2020 at the Gadhawa Rural Municipality, Dang. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amounting to a minimum of following amount, which shall be valid for 30 days beyond the validity period of the bid.
- **9.** If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
